ARTC matrices are in the process of being reviewed and updated to align with company requirements and industry standards.

The purpose of this notice is to provide an update on the upcoming changes to the ARTC Engineering Design and Project Management (EDPM) Matrix. All RIW Cardholders need to comply with the updated Engineering Design and Project Management Matrix requirements, which will be effective from **28**th **June 2024**.

Summary of changes:

- Engineering Design and Project Management matrix will now be split into two separate matrices:
 - Project Management (PM) Matrix
 - Engineering and Design (ED) Matrix
- Assessments to be conducted will use an updated Record of Relevant Experience (RORE) form
- Mandatory eLearning was introduced to provide training on ARTC processes and standards as per the previous communication released on 14th March
- Formatting changes for improved layout
- RIW system to be updated to align with the updated matrices, including renewal requirements

Your Employer administrator must upload the completed eLearning certificates for the below competencies in the Rail Industry Worker system by **28**th **June 2024**.

- Certificate.ARTC Configuration Management Training (99835)
- Certificate.ARTC Drawing Management System Training (99833)
- Certificate.ARTC Project Management Training (99834)

What are the changes in the updated Record of Relevant Experience (RORE) form?

We have updated the previous word document to a user-friendly Adobe form. Alongside this update, we have reduced the number of questions in the form to streamline and simplify the submission process.

Where can I access the updated Record of Relevant Experience (RORE) form?

You can access the updated form by visiting the ARTC Extranet.

Work with your employer to ensure your RIW profile is up to date and that you hold valid roles. All contractors and employees working on the ARTC network **must** hold a valid RIW Card and comply with the updated ARTC Engineering and Design, Project Management matrix by **28**th **June 2024** to continue working on the ARTC rail network.
